

**OTHER SERVICES**

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME.....\$2,495.00

This charge includes removal of remains, body, necessary services of staff, embalming, receptacle for transportation to airport or railroad. It does not include the services of staff or the use of the facilities for any visitation and/or rites or ceremonies prior to forwarding of the body. The cost of other than local transportation is \$ 2.50 per mile.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME .....\$2,195.00

This charge includes temporary shelter of the remains, transportation of remains to cemetery or crematory and required basic services of staff or the use of facilities.

IMMEDIATE BURIAL..... \$2,475.00 to \$12,870.00

Our charge for an immediate burial without any attendant rites or ceremonies includes removal and shelter of the remains, local transportation to cemetery and necessary services of staff and authorizations.

- 1. Immediate Burial with casket selected by purchaser in addition to the price of the casket..... \$2,475.00

DIRECT CREMATIONS ..... \$2,280.00 to \$6,045.00

Our charge for a direct cremation without any attendant rites or ceremonies includes removal and shelter of remains and transportation to crematory if local cremation, cremation and necessary services of staff and authorizations. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.) The containers we provide are made of cardboard.

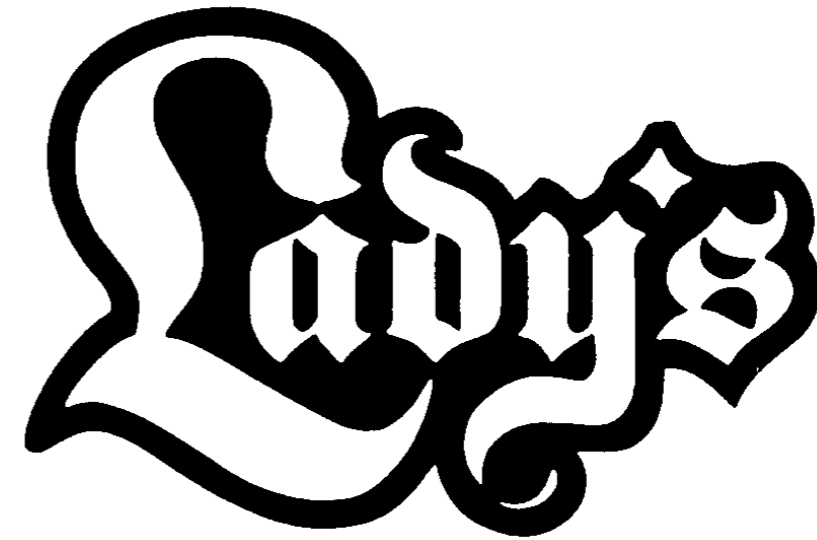

**PROFESSIONAL SERVICES**

FUNERAL DIRECTOR AND STAFF .....\$3,175.00  
 Our charge is for the time spent by the funeral director and staff in making arrangements for the funeral, consultation with the family and clergy, shelter of remains, preparation and filing of necessary notices, obtaining the authorizations and consents and coordinating with others involved with the funeral, such as the cemetery. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**PREPARATION OF THE BODY**

EMBALMING .....\$ 795.00  
 Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the Right to choose an arrangement, such as direct cremation or immediate burial that does not require you to pay for it.
