Professional and Staff Services

Coordinating Activities, Rites and Ceremonies

Professional consultation with a licensed Funeral Director, including, but not limited to, expert advice on options to meet your needs, such as disposition, rites and ceremonies, drafting notices, planning and scheduling services, advice regarding possible Government Benefits. **\$975.00**

Documentation – Permits, Forms, etc.

Completion and filing of all documents necessary to carry out services and supplies requested, including, but not limited to, death registration, burial permit, Coroner's Certificate for cremation, documentation to ship remains out of the country. We shall provide you with twelve (12) Proof of Death Certificates, which are usually accepted for most estate settlement purposes, however, occasionally a Provincial "Death Certificate" will be necessary and is available from The Office of the Registrar General. **\$425.00**

Embalming of Remains

The vascular embalming and preservation of the deceased. This process replaces bodily fluids with chemicals for the restoration, sanitation and temporary preservation. Embalming is not legally required, but may be recommended to preserve the body between the time of death and viewing, and/or disposition of the deceased. Our licensed staff will make a recommendation based on the condition of the body and expected service needs. **\$525.00**

Staff Services for Visitation

Staff to coordinate and oversee the gathering of family and friends at our premises or at another facility. Suggested times are afternoons, evenings, or one hour prior to the Ceremony. **\$325.00**

Staff Services for Celebration of Life

Staff to coordinate and oversee the Celebration of Life Ceremony on our premises or at another location, for up to 6 hours. This includes, but is not limited to, the services of a licensed funeral director and assistants to arrange the casket or urn, floral tributes, photographs and mementos, as well as directing family members and guests. **\$325.00**

Staff Services for Graveside Service

Accompaniment of the Remains to a cemetery, supervision of Graveside Service, and staff to assist with the Service. **\$325.00**

Facilities

Facilities for Preparation/Shelter

Designated room used to prepare, embalm and/or shelter the body. This charge applies whenever the remains are in our facility for any purpose. **\$225.00**

Facilities for Visitation

Designated room used for visitation. This includes use of common areas, washrooms, cloakroom, heating, lighting and maintenance. **\$495.00**

(We will scatter cremated remains in accordance with Ontario and Municipal Laws and by-laws on land. Fees for scattering from a plane or boat will be in addition to this charge and will be discussed upon request.)

Disbursements

Disbursements are items arranged for and possibly paid for on your behalf by us. These items are payable at the time a contract is entered into.

Coroner's Fee – charged by the Coroner for issuing a certificate that allows cremation to take place. This fee is set by the Chief Coroner of Ontario **\$75.00**

Municipal Death Registration – charged by the local municipality to register a death **\$44.00**

Cemetery Opening and Closing Fees – charged at cost, and payable directly to the cemetery

Clergy Fees – these apply when a member of the clergy officiates at a Church, Funeral Home, Cemetery or other venues. Fees are set by the Clergy

Church Fees - in addition to Clergy Fees, additional fees may apply to Organist, Soloist, Altar Boys, or Custodian

Newspaper Notices – also known as obituaries. Each newspaper charges per line; additional cost for a photo

Cremation – charged by the crematorium for the physical cremation of remains **\$540.00**

Police Escorts – charged by the Police Department for the use of Police Officers and their vehicles to provide escorts from the place of ceremony to the cemetery or crematorium

Circle of Life Celebrant - Certified Celebrant to act as a Master of Ceremony for a very personalized tribute **\$300.00**

Pianist/Soloist **\$200.00**

Pipers/Buglers **\$300.00**

Refundable Deposit for Cremated Remains – When human remains are to be cremated, a refundable deposit will be required to be paid. If the cremated remains are not claimed within one year of the cremation, the deposit may be used to inter the cremated remains in common ground. If the cremated remains are claimed before they are interred, the deposit will be refunded. **Circle of Life does not charge this deposit** **\$350.00**

Payment

To lose someone you love can be a devastating experience. It is quite often traumatic and can seriously impact judgement. We believe in the importance of honouring and remembering the life that has been lived and will do our best to meet your needs at this difficult time with kindness, caring and respect for the family and the loved one who has passed on.

Funerals can be costly, and we want to make sure that we can be of assistance to suit any budget. We do not want a family to spend more than they would like or can afford. In some cases, your loved one may be eligible for social assistance to help pay for funeral and burial/cremation costs.

Unless otherwise discussed, payment is due at the time of signing the contract. Payment can be made by cash, cheque, Debit Card, VISA or Mastercard. Pre-arranged services are payable by cheque only.

Prepayment

We offer two (2) funding options when prearranging services and supplies. When prepaying, you pay for the services and supplies today and the money will be used for services and supplies when they are needed at the time of death. Monies paid are not deposited into the Funeral Home account, they are held by an Insurance Company or Trust Company, where they will accrue interest until they are needed.
