Includes post office & radio notices, coordination with clergy/cemetery Cremation with memorial services at another facility (personnel not required)

DIRECT CREMATION \$1575.00

Our charge for direct cremation, (without ceremony) includes, removal of remains; cremation, necessary minimum services of staff and authorizations and includes coordination with outside agencies; refrigeration and disinfecting (unembalmed). If you want to arrange a direct cremation, you can use an unfinished wood box or alternative container. Alternative containers can be made of material like heavy cardboard or composition materials (with or without outside covering) or pouches of canvas.
